This agreement is between you ("Licensee") and Nir Zabari Yenni ("Licensor"). By downloading, installing, or using the Font Software, you accept the terms below. This license grants rights to use the fonts as specified and does not transfer ownership.

GENERAL TERMS

- The Font Software is licensed, not sold.
- All rights not expressly granted remain with the Licensor.
- Fonts are protected under international copyright and design law.

LICENSE TYPES

DESKTOP LICENSE

You may install the fonts on licensed devices and use them in design applications for print and digital publications, logos, branding, visual identity, internal presentations, and static visuals. This license does not permit embedding in websites or apps, or use by unlicensed collaborators.

WEB LICENSE

You may use the fonts on websites you own or control, using @font-face and self-hosted font files (WOFF/WOFF2 only). The license covers unlimited traffic with no tracking required, and applies to one organization per brand. This license does not permit hosting fonts on public or third-party servers, or reuse across unrelated brands or clients.

APP LICENSE

You may embed the fonts in one mobile or desktop application title. The license covers all platforms and versions, and allows unlimited downloads and updates. It does not permit embedding in multiple apps or use outside the app context (such as for web or print).

TRIAL LICENSE

A free trial license allows you to test the fonts before purchasing a full license. You may use trial fonts for internal evaluation, mockups, or presenting design directions to clients—strictly for non-commercial purposes.

COMPANY SIZE

License levels reflect the size of the organization. Licenses are available for:

- Individual: One person (e.g., freelancer)
 - Small Studio: A small team (up to 5 users)
 - Company: Larger organizations, scalable by number of users
- Company licenses may be extended to external contractors by purchasing an add-on license.

STUDENT & EDUCATIONAL USE

A 50% discount is available for students and accredited institutions. Proof is required.

RESTRICTIONS

Licensees may not:

- Modify, alter, or reverse-engineer the fonts
- Resell, sublicense, or redistribute the fonts
- Share fonts with third parties not covered by the license
- Upload the fonts to public servers, repositories, or platforms
- Use the fonts in unlawful, hateful, or discriminatory contexts

TERMINATION

Any breach of this agreement terminates the license. Upon termination, all copies must be deleted.

LIABILITY AND WARRANTY

The Font Software is provided "as is" without warranties. Licensor is not liable for damages resulting from its use.

GOVERNING

This agreement is governed by the laws of the State of Israel. Any disputes shall be settled in the competent courts of Tel Aviv.
